A RESOLUTION

HONORING, COMMENDING AND CELEBRATING BROAD VIEW EYE CENTER ON BEING NAMED THE 2019 RECIPIENT OF THE BEREA CHAMBER OF COMMERCE RISING STAR AWARD.


