A RESOLUTION

APPROVING AND AUTHORIZING THE CHANGE OF THE NAME OF THE OUTDOOR MUNICIPAL POOL TO THE DAVE TRESSEL MEMORIAL POOL.

WHEREAS, Dave Tressel, who passed away on February 11, 2022, was a lifelong resident of the City of Berea; and

WHEREAS, Dave was the proud son of legendary Baldwin-Wallace Coach Lee Tressel and his wife, Eloise Tressel; and

WHEREAS, Dave attended Berea City Schools and received his undergraduate degree from Baldwin-Wallace in 1973 and a Master of Arts in Education in 1978; and

WHEREAS, Dave served as a teacher and coach in the Berea City School District for over 35 years at both Roehm Middle School and Berea High School; and

WHEREAS, while serving as teacher and coach, Dave also dedicated himself to community service, as president of the Berea Kiwanis Club, BW Alumni Council, as a member of the Coe Lake Nature Trail Committee and as a board member of the Berea Historical Society; and

WHEREAS, Dave demonstrated his commitment to the youth of Berea by volunteering with Realizing Your Potential, a mentoring group for African-American Berea High male students and with the Berea Kiwanis sponsored Builder's Club for middle school students; and

WHEREAS, following his teaching career, Dave continued to serve the community as a member of the Berea City School Board; and

WHEREAS, Dave was honored in 2012 by being inducted into the BW Hall of Fame and, again, in 2013 as the recipient of the Berea Grindstone Award; and

WHEREAS, in addition to all of his other achievements, Dave Tressel also dedicated his life to swimming and diving, first as a competitor, and second, by serving as a coach at both Berea High School and Baldwin-Wallace University; and

WHEREAS, perhaps his greatest service was to the youth of Berea through his participation and leadership in the City of Berea Recreation Department's Learn to Swim Program, where he taught and coached for over 45 years; and

WHEREAS, Dave Tressel is responsible for teaching thousands of Berea's youths how to swim and left an indelible mark on each and every one of them; and

WHEREAS, the Mayor, Administration and Council of the City of Berea wish to honor the extraordinary service and legacy of Dave Tressel by renaming the outdoor pool as the Dave Tressel Memorial Pool.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Berea, State of Ohio:


SECTION 1. That the Berea Municipal Outdoor Pool shall be, and is hereby renamed the Dave Tressel Memorial Pool.

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the approval of this Resolution were approved in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


SECTION 3. That this Resolution shall take effect and be in force immediately upon passage and approval by the Mayor.
