

MINUTES OF A REGULAR COUNCIL MEETING
January 5, 2026 - 7:30p.m.

Council of the City of Berea, Ohio, met in regular session in the Council Chamber on January 5, 2026 and the meeting was called to order by President of Council Jim Maxwell at 7:30p.m. Present: Erika Coble, Michael A. Kurtz, Chris McManis, Vance Redding, Rick Skoczen, and Lisa Weaver. Also present: Mayor Cyril M. Kleem, Director of Public Service Tony Armagno, Director of Law and Public Safety Barb Jones and Director of Finance Andrea Morris.

Moved by Mrs. Weaver, seconded by Mr. Skoczen, that the minutes from the December 15, 2025 Regular Council Meeting be approved. Vote on the motion was all ayes and no nays. The motion carried.

LEGISLATION – FIRST READING:**RESOLUTION NO. 1-1: A RESOLUTION SUPPORTING THE 2026 CELEBRATION OF THE ANNIVERSARY OF THE BIRTH OF DR. MARTIN LUTHER KING, JR.**

The Clerk read the title of the Resolution.

Moved by Mrs. Weaver, seconded by Mr. Skoczen, that Resolution No. 1-1 be approved. Vote on the motion was ayes: Coble, Kurtz, McManis, Redding, Skoczen and Weaver. Nays: None. The motion carried.

ORDINANCE NO. 1-2: AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO ENTER INTO AN AGREEMENT WITH CUYAHOGA SOIL AND WATER CONSERVATION DISTRICT TO PROVIDE TECHNICAL ASSISTANCE IN IMPLEMENTING SOIL AND WATER CONSERVATION MEASURES, AND DECLARING AN EMERGENCY.

The Clerk read the title of the Ordinance.

Mr. Armagno explained that the City contracts with Cuyahoga Soil and Water Conservation District for several services relating to stormwater ordinances and EPA requirements during and after construction. This agreement would continue those services through 2026, with an option for 2027.

Mr. Kurtz asked if it is common for the City to have to add funds for a project, and Mr. Armagno replied that it has not happened yet.

Proposed Ordinance No. 1-2 stands on first reading.

ORDINANCE NO. 1-3: AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO ENTER INTO A LISTING AGREEMENT WITH A PROFESSIONAL REALTOR FOR THE MARKETING AND SALE OF 280 KEMPTON DRIVE, AND TO SUBSEQUENTLY, AND UPON THE APPROVAL OF BOARD OF CONTROL, ENTER INTO A STANDARD RESIDENTIAL PURCHASE AGREEMENT FOR THE SALE OF 280 KEMPTON DRIVE, WHICH IS NO LONGER NEEDED FOR MUNICIPAL PURPOSES, TO THE PERSON OR ENTITY SUBMITTING THE HIGHEST AND BEST OFFER, AND TO EXECUTE ALL DOCUMENTS RELATED TO THE SALES, AND DECLARING AN EMERGENCY.

The Clerk read the title of the Ordinance.

Mr. Maxwell reminded Council that the City received this property through the Land Bank several weeks ago, but as it is not yet transferred to the City, the inside condition is unknown. Once transferred, the intent is for the City to hire a professional realtor to market the property.

In response to an inquiry from Mr. McManis, Mrs. Jones said that the City will be doing no substantial improvements to the property before it is sold. Any costs incurred will be recouped from the sale of the property, but most of the work will be done in-house.

General discussion commenced concerning the potential for a tax abatement on any addition to this property.

Proposed Ordinance No. 1-3 stands on first reading.

There being no further business before Council, it was moved by Mr. McManis, and seconded by Mrs. Weaver, that the Regular Council Meeting be adjourned. Vote on the motion was all ayes and no nays. The motion passed and President Maxwell declared the meeting adjourned at 8:02p.m.
