## A RESOLUTION

### SUPPORTING THE GRANT APPLICATION OF THE CITY OF BEREA TO THE CUYAHOGA COUNTY BROWNFIELD REDEVELOPMENT FUND COMMUNITY ASSESSMENT INITIATIVE.

WHEREAS, it is necessary to conduct environmental assessments of the properties located at 731, 739, 746, 756, 757 and 785 Front Street, Berea, Ohio 44017 and identified by the Cuyahoga County Fiscal Office as Permanent Parcel Numbers 362-02-003, 362-02-005, 362-02-006, 362-02-009, 362-02-011, 362-03-002, 362-03-013, and 362-03-014; and

WHEREAS, there is funding available for the environmental assessments of these properties through the Cuyahoga County Brownfield Redevelopment Fund Community Assessment Initiative; and

WHEREAS, the City desires to submit an application for a grant to fund the environmental assessments of these properties through the Cuyahoga County Brownfield Redevelopment Fund Community Assessment Initiative; and

WHEREAS, the City will work in conjunction with Dmark Development to redevelop these properties as part of the North End Redevelopment Project; and

WHEREAS, the Council of the City of Berea desires to support this application for grant funding through the Cuyahoga County Brownfield Redevelopment Fund Community Assessment Initiative.


NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Berea, State of Ohio:


