RESOLUTION NO. 2018-41

HONORING AND COMMENDING MORGAN TARANTOWSKI  
FOR HIS ACHIEVEMENT IN ATTAINING THE RANK OF EAGLE SCOUT.

*WHEREAS*, the highest rank in the Boy Scouts of America is that of Eagle Scout; and

*WHEREAS*, Morgan Tarantowski is a 2017 graduate of Berea-Midpark High School where he was the Captain of the cross country team, and a member of both the wrestling and track and field teams; and

*WHEREAS*, Mr. Tarantowski attends Baldwin Wallace University, where he is majoring in Sustainability; and

*WHEREAS*, Mr. Tarantowski was a member of Boy Scout Troop 228, chartered by the United Methodist Church of Berea, and diligently served as Senior Patrol Leader, Troop Guide and Quartermaster; and


**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Berea, State of Ohio:



**SECTION 3.** That this Resolution shall take effect and be in force immediately upon its passage and approval by the Mayor.




