A RESOLUTION

HONORING, COMMENDING AND CELEBRATING PAUL ANZALONE ON BEING NAMED A 2019 RECIPIENT OF THE BEREA CHAMBER OF COMMERCE COURTESY AWARD.

WHEREAS, the Berea Chamber of Commerce holds an annual Grindstone Award Banquet for the purpose of honoring, recognizing and celebrating outstanding members of our community; and

WHEREAS, the Berea Chamber of Commerce Courtesy Award identifies and acknowledges community members who have displayed exemplary courtesy in their line of work, going above and beyond in their service to the general public; and

WHEREAS, a recipient of the 2019 Courtesy Award is Paul Anzalone, the Director of Public Service for the City of Berea; and

WHEREAS, Mr. Anzalone is one of those rare individuals that almost everyone truly likes, but that everyone absolutely respects; and

WHEREAS, Mr. Anzalone possesses a work ethic that is second to none, holding himself to a higher standard than he does anyone else, and never passing work to his crews that he is not willing to participate in himself; and


NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Berea, State of Ohio:


