A RESOLUTION

WHEREAS, one nominator declared, Mr. Bollin "is someone many look up to in the District, and not just because he is noticeably taller than everyone else!"


NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Berea, State of Ohio:



SECTION 3. That this Resolution shall take effect and be in force immediately upon its passage and approval by the Mayor.


