## A RESOLUTION

HONORING, COMMENDING AND CELEBRATING NATALIE STEWART ON BEING NAMED A 2019 RECIPIENT OF THE BEREA CHAMBER OF COMMERCE COURTESY AWARD.


NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Berea, State of Ohio:




