RESOLUTION NO. 2019-46

**HONORING AND COMMENDING RYAN O'FLANAGAN  
FOR HIS ACHIEVEMENT IN ATTAINING THE RANK OF EAGLE SCOUT.**

*WHEREAS*, the highest rank in the Boy Scouts of America is that of Eagle Scout; and

*WHEREAS*, Ryan O'Flanagan is a senior at Berea-Midpark High School where he is a member of the Junior Statesmen of America, assists with the Coe Lake Outdoor Science Education program (CLOSE), and is both a LINK leader and student mentor; and

*WHEREAS*, Mr. O'Flanagan will be attending the University of Findlay to pursue a degree in Early Childhood Education; and

*WHEREAS*, Mr. O'Flanagan is a member of Boy Scout Troop 215, sponsored by the Berea Elks Lodge, and diligently served as Senior Patrol Leader for three years, while currently occupying the position of Assistant Scoutmaster for the Troop; and

*WHEREAS*, Mr. O'Flanagan has been a volunteer at Grindstone Elementary School for the past three years, and successfully completed an Eagle Scout service project during which he designed, built and led other Troop Members and adult helpers in the creation of wheeled bookcases and curtains for Mr. John Kruggel's kindergarten classroom, a project that took 168 total volunteer hours to coordinate and complete; and

*WHEREAS*, Mr. O'Flanagan, through his hard work and personal dedication to the ideals of Scouting, and with the help, guidance and unconditional support of his Parents, Delett & Terry O'Flanagan, his Grandparents, Lola and Charles Kugel, his first grade teacher, John Kruggel and his former Scoutmaster and his wife, Doug and Tammy Runyon, has completed and fulfilled the necessary requirements, whereby achieving the distinguished rank of Eagle Scout.


**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Berea, State of Ohio:

**SECTION 1.** That the Mayor of the City of Berea, the President and all Members of Council and the Officers of the Administration do hereby honor, commend and congratulate Ryan O'Flanagan on attaining the rank of Eagle Scout and, furthermore, express their sincere admiration for the time and effort that Mr. O'Flanagan so admirably dedicated in order to achieve and advance the highest ideals of Scouting.


