A RESOLUTION

HONORING AND CELEBRATING THE 2021 RECIPIENTS OF THE BEREA CHAMBER OF COMMERCE COURTESY AWARD.

WHEREAS, 2021 Courtesy Award recipient Jim Bycznski, Art Teacher at Berea-Midpark High School, is a compassionate, empathetic and inspiring educator who has crafted a truly unique visual effects program that has transformed the imaginations, passions and paths of his students; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Berea, State of Ohio:




SECTION 3. That this Resolution shall take effect immediately upon its passage and approval by the Mayor.
