### A RESOLUTION

#### HONORING AND CELEBRATING THE 2022 RECIPIENTS OF THE BEREA CHAMBER OF COMMERCE FUTURE LEADER AWARD.

**WHEREAS**, the Berea Chamber of Commerce holds an annual Grindstone Award Banquet for the purpose of honoring, recognizing and celebrating outstanding members of our community; and

**WHEREAS**, the newly established Berea Chamber of Commerce Future Leader Award identifies and acknowledges high school or college students who are excelling in both their areas of study and their service to the greater community; and

**WHEREAS**, 2022 Future Leader Award recipient Lillian Henry, a junior at Ohio University, has volunteered at a host of Vacation Bible Schools and with the North End Foundation, served her Parish as an altar server, lector and Parish Faith Formation teacher, was active in her high school as a member of Student Council and Key Club, serving as a Link Team Leader and a Camp Mi-Bro-Be Counselor, as well as participating in several events with the Berea Chamber of Commerce; and

**WHEREAS**, 2022 Future Leader Award recipient Rose Henry, a junior at Berea-Midpark High School, began volunteering as a toddler through the Caring Cubs program, continuing her service at St. Adalbert's Parish in yearly stewardship activities, and as a Girl Scout, raking leaves, caroling at Christmas and cleaning up Coe Lake, as well as participating in many events with the Berea Chamber of Commerce; and

**WHEREAS**, 2022 Future Leader Award recipient Thomas Henry, a junior at Berea-Midpark High School, also began volunteering through Caring Cubs before continuing service at a multitude of Vacation Bible Schools, at St. Adalbert's as an altar server and Works of Mercy Stewardship program volunteer and through both Cub Scouts and Boy Scouts, placing flags on Military tombstones and serving Thanksgiving dinner to Veterans, as well as participating in numerous events with the Berea Chamber of Commerce; and

**WHEREAS**, 2022 Future Leader Award recipient Andy Scott is involved in school activities and clubs, volunteers with Labre to give food to the homeless, works in the tech booth during services at Grace Church, while also teaching Sunday School to the younger children, and has earned a number of awards, both for academics and service, including the Kiwanis Club of Berea Citizenship Award, the Merit Scholarship Award from St. Mary's School, the Scholastic Achievement High Honors Award and Public Speaker of the Year award from St. Edward's High School, and was given the Pay It Forward Scholarship, which is bestowed upon Saint Edward's students who show kindness to fellow classmates and are making a difference at the high school; and

**WHEREAS**, it is important to acknowledge the tremendous works of compassion, kindness and service demonstrated by these four worthy individuals, and honor them as future leaders in our community and beyond.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Berea, State of Ohio:

**SECTION 1.** That the President and all Members of Council do hereby honor and celebrate the 2022 recipients of the Chamber of Commerce Future Leader Award: Lillian Henry, Rose Henry, Thomas Henry and Andy Scott, and do, with grateful hearts, extend our most sincere appreciation and respect to them for the multitude of ways in which they care for and serve the residents of Berea and our neighboring communities.


**SECTION 3.** That this Resolution shall take effect immediately upon its passage and approval by the Mayor.


