## **AN ORDINANCE**

### **AMENDING CHAPTER 105, WARDS AND BOUNDARIES, OF THE CODIFIED ORDINANCES OF THE CITY OF BERE, AND DECLARING AN EMERGENCY.**

**BE IT ORDAINED** by the Council of the City of Berea, State of Ohio:

**SECTION 1.** That Chapter 105, Wards and Boundaries, of the Codified Ordinances of the City of Berea, which has heretofore read as follows:

#### **105.01 WARDS ESTABLISHED.**

For the purpose of electing members of Council in the year 1993 and thereafter, and pursuant to the provisions of Section IV, Item 9, of the Charter of the City, the City shall be, and hereby is, divided into five wards, which wards are particularly defined and described as follows: (Ord. 92-74. Passed 6-29-92.)

#### **105.02 WARD ONE.**

Beginning in the Northerly Corporation line of the City of Berea at its intersection with the centerline of the East Branch of Rocky River;

Thence Easterly along the Northerly Corporation line of the City of Berea and along the centerline of Sheldon Road to its intersection with the centerline of Eastland Road;

Thence Southerly along the centerline of Eastland Road to its intersection with the Southeasterly line of the Consolidated Rail Corporation right of way;

Thence Southwesterly along the Southeasterly line of the Consolidated Rail Corp. right-of-way line to its intersection with an Easterly Corporation line of the City of Berea;

Thence Southerly along such Easterly Corporation line to a Northerly Corporation line of the City of Berea;

Thence Easterly along such Northerly Corporation line to its intersection with the centerline of Eastland Road;

Thence Southerly along the centerline of Eastland Road to its intersection with a Northerly Corporation line of the City;

Thence Southerly along such Easterly line of Sublot Number 9 and its prolongation Southerly to its intersection with the centerline of Barberry Drive;

Thence Westerly along the centerline of Barberry Drive to its intersection with the centerline of Maple Avenue;

Thence Southerly along the centerline of Maple Avenue to its intersection with the centerline of Bagley Road;

Thence Westerly along the centerline of West Center Street to its intersection with the centerline of the East Branch of Rocky River;

Thence Northwesterly along the centerline of the East Branch of Rocky River to its intersection with the Northerly Corporation line of the City and the place of beginning.

### **105.03 WARD TWO.**

Beginning at the Northwesterly corner of Original Middleburg Township Section Number 24 and a Northerly Corporation line of the City of Berea;

Thence Easterly along such line to its intersection with the centerline of East Branch of the Rocky River at the point at which it bears Southerly;

Thence Northerly along the Easterly line of Lewis Road and crossing Bagley Road to the Northerly line of the Conrail Railroad right-of-way;

Thence Easterly along the Northerly irregular line of said Consolidated Rail Corporation to the Westerly line of land conveyed to June Scanlon by deed recorded in Volume 15417, Page 651 of Cuyahoga County Deed Records;

Beginning in the centerline of West Bridge Street at its intersection with the centerline of the Metropolitan Park Drive;

Thence South along the centerline of State Route 237 (aka Henry Street which then is aka Prospect Road) to its intersection with the centerline of West Street;

Thence Westerly along the centerline of West Street to its intersection with the centerline of Crocker Street;

Thence Southerly along the centerline of Crocker to its intersection with the centerline of Crosby Street;

Thence Westerly along the centerline of Crosby to its intersection with the centerline of Fair Street;

Thence Southerly along the centerline of Fair Street Road to its intersection with the centerline of Fairpark Drive;

Thence Westerly and then continuously meandering and running in the same momentum along the Corporation line of the City of Berea to a point of intersection with the centerline of West Street, which is at a meeting point with the Western border of Ward 3 and adjacent to the northern property line of P.P. # 363-27-278;

Thence Easterly along the centerline of Crosby Street to its intersection with the centerline of Crocker Street;

Thence Northerly along the centerline of Crocker Street to its intersection with the centerline of West Street;

Thence Easterly along the centerline of West Street to its intersection with the centerline of State Route 237 (aka Prospect Road)

Thence Northerly along the centerline of State Route 237 (aka Prospect Road) to its intersection with West Bridge Street

Thence Easterly along the centerline of West Bridge Street to its intersection with the centerline of Valley Parkway, being the place of beginning.

**SECTION 2.** That existing Chapter 105 of the Codified Ordinances of the City of Berea be and the same is hereby repealed.

**SECTION 3.** That it is found and determined that all formal actions of this Council concerning and related to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this council and any of its committees that resulted in such actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare, and for the further reason that it is immediately necessary to get the new ward boundaries to the Board of Elections in order that the board may have sufficient time to establish, define, divide, rearrange and combine the several election precincts and change the location of the polling place for each precinct for the elections to be held in the City of Berea. Therefore, provided this ordinance receives the affirmative vote of two-thirds of all of the members elected to this Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise, from and after the earliest period allowed by law.
