## AN ORDINANCE

**AUTHORIZING THE MAYOR TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT IN CONCERT WITH THE CITY OF STRONGSVILLE, CITY OF BROOK PARK, CITY OF MIDDLEBURG HEIGHTS, CITY OF NORTH ROYALTON, CITY OF OLMSTED FALLS, OLMSTED TOWNSHIP AND THE CHAGRIN VALLEY DISPATCH COUNCIL, FOR THE PURCHASE OF A COMPUTER ASSISTED DISPATCH SOFTWARE PROGRAM FROM MOTOROLA, APPROPRIATING FUNDS THERETO, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Cities of Berea, Strongsville, Brook Park, Middleburg Heights, North Royalton, Olmsted Falls, Olmsted Township and the Chagrin Valley Dispatch Council are all political subdivisions of the State of Ohio; and

**WHEREAS**, various provisions in the law, including Ohio Revised Code Sections 9.48, 9.482 and 735.053, provide that a political subdivision may authorize the appropriate official to enter into a contract, without advertising and bidding, for the purchase of material, equipment, or supplies from another Ohio political subdivision; and

**WHEREAS**, the Chagrin Valley Dispatch Council is purchasing Computer Assisted Dispatch (CAD) software from Motorola, and has agreed to make such software available to members of the Southwest Emergency Dispatch Center, hosted by the City of Strongsville; and

**WHEREAS**, all parties to the Intergovernmental Agreement will benefit by taking advantage of the pricing available to the Chagrin Valley Dispatch Council; and

**WHEREAS**, the City of Berea and the other Agencies listed herein are desirous of using said Motorola CAD software system for their purposes.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Berea, State of Ohio:

**SECTION 1.** That the Mayor is authorized to enter into an Intergovernmental Agreement along with the Cities of Strongsville, Brook Park, Middleburg Heights, North Royalton, Olmsted Falls and Olmsted Township, with the Chagrin Valley Dispatch Council, for the purchase of a Computer Assisted Dispatch software program from Motorola at a total cost to the City of Berea of Two Hundred Fifty Thousand Eighty-Nine Dollars (\$250,089.00) paid in ten annual installments of Twenty-Five Thousand and Eight Dollars and Ninety Cents (\$25,008.90) in accordance with the terms and conditions set forth in Exhibit "A", which is attached hereto and made a part hereof, as if fully rewritten herein;

**SECTION 2.** That the Director of Finance be, and hereby is, authorized and directed to pay out such agreement sum(s) and charge the same to, and the funds therefor are hereby appropriated from the General Fund, designated for accounting purposes as Fund No. 100 for the purpose set forth in Section 1.

**SECTION 3.** That is if found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health safety and welfare, or providing for the usual daily operation of a municipal department, and for the further reason that the Chagrin Valley Dispatch Council requires that their Agreements with the Agencies be finalized before the end of January 2023. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
