## AN ORDINANCE

### **AUTHORIZING THE MAYOR OF THE CITY OF BEREAL TO ENTER INTO A CONTRACT WITH THE GENERAL HEALTH DISTRICT OF CUYAHOGA COUNTY, OHIO, PROVIDING FOR HEALTH SERVICES FOR THE CITY OF BEREAL FOR YEARS 2024 AND 2025.**

**WHEREAS**, a proposed contract between the General Health District of Cuyahoga County, Ohio, and the City of Berea, a copy of which is attached hereto as Exhibit "A" and incorporated herein by reference, has been presented to the Council providing for health services for the City of Berea for the Years 2024 and 2025; and

**WHEREAS**, by the provisions of said contract, the General Health District of Cuyahoga County agrees to provide through the District Board of Health of Cuyahoga County, all necessary medical, nursing, sanitary, laboratory and such other health services as are required by the Statutes of the State of Ohio; and

**WHEREAS**, according to the terms of said contract, the City of Berea agrees, in return for the health services which will be provided by the District Board of Health of Cuyahoga County for the Year 2024, to pay the said District the sum of One Hundred Thirty-Four Thousand and Four Hundred and Fifty-One Dollars (\$134,451.00) in equal semi-annual installments of Sixty-Seven Thousand Two Hundred Twenty-Five Dollars and Fifty Cents (\$67,225.50) from the regular tax settlement to be made for said City of Berea for the Year 2024; and

**WHEREAS**, according to the terms of said contract, the City of Berea agrees, in return for the health services which will be provided by the District Board of Health of Cuyahoga County for the Year 2025, to pay the said District the sum of One-Hundred Forty-Eight Thousand Three-Hundred and Sixty Dollars (\$148,360.00) in equal semi-annual installments of Seventy-Four Thousand One-Hundred and Eighty Dollars (\$74,180.00) from the regular tax settlement to be made for the City of Berea for the Year 2025.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Berea, State of Ohio:

**SECTION 1.** That the Mayor of the City of Berea, Ohio, be and hereby is authorized and directed to enter into a contract with the General Health District of Cuyahoga County for health services for the City of Berea for the Year 2024 and Year 2025 in the form attached hereto as Exhibit "A" and incorporated herein by reference.

**SECTION 2.** That the Director of Finance be, and hereby is authorized and directed to pay out the contract sum of One Hundred Thirty-Four Thousand and Four Hundred and Fifty-One Dollars (\$134,451.00) in equal semi-annual installments of Sixty-Seven Thousand Two Hundred Twenty-Five Dollars and Fifty Cents (\$67,225.50) from the regular tax settlement to be made for said City of Berea for the Year 2024 and the sum of One-Hundred Forty-Eight Thousand Three-Hundred and Sixty Dollars (\$148,360.00) in equal semi-annual installments of Seventy-Four Thousand One-Hundred and Eighty Dollars (\$74,180.00) from the regular tax settlement to be made for said City of Berea for the Year 2025, and to charge the same to, and the funds therefor are hereby appropriated from the General Fund, designated for accounting purposes as Fund No. 100 for the purposes as set forth in Section 1 above.

**SECTION 3.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4.** That this Ordinance shall take effect from and after the earliest period allowed by law.
