### AN ORDINANCE

**AUTHORIZING AND RATIFYING THE DIRECTOR OF PUBLIC SERVICE TO ADVERTISE FOR BIDS AND ENTER INTO ONE OR MORE CONTRACT(S) FOR THE PURCHASE OF VARIOUS PRODUCTS AND SERVICES FOR THE DAY-TO-DAY OPERATIONS OF THE CITY OF BEREA'S SERVICE DEPARTMENT, AND DECLARING AN EMERGENCY.**

**BE IT ORDAINED** by the Council of the City of Berea, State of Ohio:

**SECTION 1.** That the Director of Public Service be, and he hereby is, authorized to advertise for bids and, after approval by the Board of Control, to enter into one or more contracts for 2024 with the lowest responsive and responsible bidder(s) for the purchase of various products and services for the day-to-day operations of the City's Service Department, all in accordance with specifications on file in the office of the Director of Public Service, and ratifying the same.

## ORDINANCE NO. 2023-53

**SECTION 4.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare, or providing for the usual daily operation of a municipal department, and for the further reason that the operations of the Public Service Department require the frequent acquisition of new and updated equipment at the best obtainable price in order to maintain and carry on their usual day-to-day operations. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
