### A RESOLUTION

#### **APPROVING THE CUYAHOGA COUNTY 911 PLAN AS ADOPTED BY THE CUYAHOGA COUNTY 9-1-1 PROGRAM REVIEW COMMITTEE, PURSUANT TO SECTION 128.08 OF THE OHIO REVISED CODE, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the City of Berea is located within the County of Cuyahoga, and is therefore part of Cuyahoga County's 9-1-1 service network; and

**WHEREAS**, pursuant to Section 128.06(D) of the Ohio Revised Code, each 9-1-1 committee shall maintain and amend a final plan for implementing and operating a county 9-1-1 system with specific provisions included therein; and

**WHEREAS**, Cuyahoga County has provided a copy of the 9-1-1 Plan, dated March 6, 2024 in accordance with Ohio Revised Code Section 128.07; and

**WHEREAS**, pursuant to Ohio Revised Code Section 128.08(A), within sixty days after receipt of the final plan, the legislative authority of each municipal corporation in the county whose territory is proposed to be included in a county 9-1-1 system shall act by resolution to approve or disapprove the plan.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Berea, County of Cuyahoga, State of Ohio:

**SECTION 1.** That this Council hereby approves the Cuyahoga County 911 Plan, as adopted by the Cuyahoga County 9-1-1 Program Review Committee, such Cuyahoga County 911 Plan being attached hereto and incorporated herein, by reference, as Exhibit A.

**SECTION 2.** That it is found and determined that all formal actions of this Council concerning and relating to the approval of this Resolution were approved in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 3.** That this Resolution, adopted pursuant to ORC Section 128.08, is an administrative measure not subject to recall and, therefore, provided that this Resolution
