## **AN ORDINANCE**

### **REPEALING AND REPLACING CHAPTER 1331, RESIDENTIAL RENTAL PROPERTY PERMITS, OF THE CODIFIED ORDINANCES OF THE CITY OF BEREA TO INCLUDE REGISTRATION REQUIREMENTS AND PROCEDURES FOR BOTH LONG-TERM AND SHORT-TERM RESIDENTIAL RENTAL PROPERTIES.**

**WHEREAS**, there has been an increase in the number of both long-term and short-term rentals in the City of Berea; and

**WHEREAS**, short-term rentals, while often managed responsibly, can also draw transient guests who may not be as invested in a community's well-being and may negatively impact residents' enjoyment of their own properties due to noise, trash and other safety concerns; and

**WHEREAS**, short-term renters may not be aware of local Ordinances, leading to disturbances and involvement of local public safety forces; and

**WHEREAS**, without local supervision, there exists a greater risk of incidents requiring public safety and service assistance, as well as a lack of accountability for property damage, guest behavior and/or guests' well-being and safety; and

**WHEREAS**, it is difficult and time-consuming to manage and enforce existing regulations for both long-term and short-term rentals, especially if they are operating without the knowledge of City officials; and

**WHEREAS**, Chapter 1331 should be revised to specifically include short-term rentals to provide for the safety and well-being of residents, property owners and transient guests of the City of Berea; and

**WHEREAS**, it is important to streamline the permit approval process for both long-term and short-term rentals, to provide a meaningful appeal process.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Berea, State of Ohio:

**SECTION 1.** That Chapter 1331, Residential Rental Property Permits, of the Codified Ordinances of the City of Berea, which is attached hereto as Exhibit A and incorporated herein by reference, shall be expressly repealed and replaced by new Chapter 1331, Residential Rental Property Permits, which is attached hereto as Exhibit B and incorporated herein by reference.
