AN ORDINANCE

AUTHORIZING AND RATIFYING THE DIRECTOR OF PUBLIC SERVICE TO ADVERTISE FOR BIDS AND ENTER INTO ONE OR MORE CONTRACT(S) FOR THE PURCHASE OF VARIOUS PRODUCTS AND SERVICES FOR THE DAY-TO-DAY OPERATIONS OF THE CITY OF BEREA'S SERVICE DEPARTMENT, AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Council of the City of Berea, State of Ohio:

SECTION 1. That the Director of Public Service be, and he hereby is, authorized to advertise for bids and, after approval by the Board of Control, to enter into one or more contracts for 2026 with the lowest responsive and responsible bidder(s) for the purchase of various products and services for the day-to-day operations of the City's Service Department, all in accordance with specifications on file in the office of the Director of Public Service, and ratifying the same.

SECTION 2. That the Director of Finance be, and hereby is, authorized to pay out such contract sums, and to charge the same to, and the funds therefor are hereby appropriated from the above-listed funds.

SECTION 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare, or providing for the usual daily operation of a municipal department, and for the further reason that the operations of the Public Service Department require the frequent acquisition of new and updated equipment at the best obtainable price in order to maintain and carry on their usual day-to-day operations. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
